**REPORT OF FACTUAL FINDINGS WITH RESPECT TO PUBLIC BENEFIT ORGANISATION STATUS AND BBBEE RATING**

Dear Sirs,

**Scope**

We have performed the procedures agreed with you and enumerated below with respect to confirming BBBEE rating and not for profit status for the **SOUTH AFRICAN POULTRY ASSOCIATION Public Benefit Organisation number 18/11/2/1906** (the "Entity") as at 12 December 2012. Our engagement was undertaken in accordance with the International Standard on Related Services applicable to agreed-upon procedures engagements. Our procedures were performed to assist you in confirming the BBBEE rating and not for profit status as at 31 December 2012.

Our procedures consisted of:

1. Inspection of SARS correspondence to confirm the tax status.
2. Inquiries from management regarding BBBEE rating and review of the minutes of management meetings.

**Findings**

1. With respect to procedure 1, we confirm **SOUTH AFRICAN POULTRY ASSOCIATION** is a registered Public Benefit Organisation and is exempt from Income tax.
2. Based on enquiries with Management and a review of the minutes of management meetings, we confirm no BBBEE rating was obtained nor planned for the foreseeable future.

Because the above procedures and findings are not as a result of an engagement in accordance with International Standards on Auditing, International Standards on Review Engagements or International Standards on Assurance Engagements, we do not express any assurance on the information provided in this certificate. Had we performed additional procedures or had we performed an assurance engagement in terms of the International Standards referred to in this paragraph, other matters might have come to our attention that may have been reported to you.
