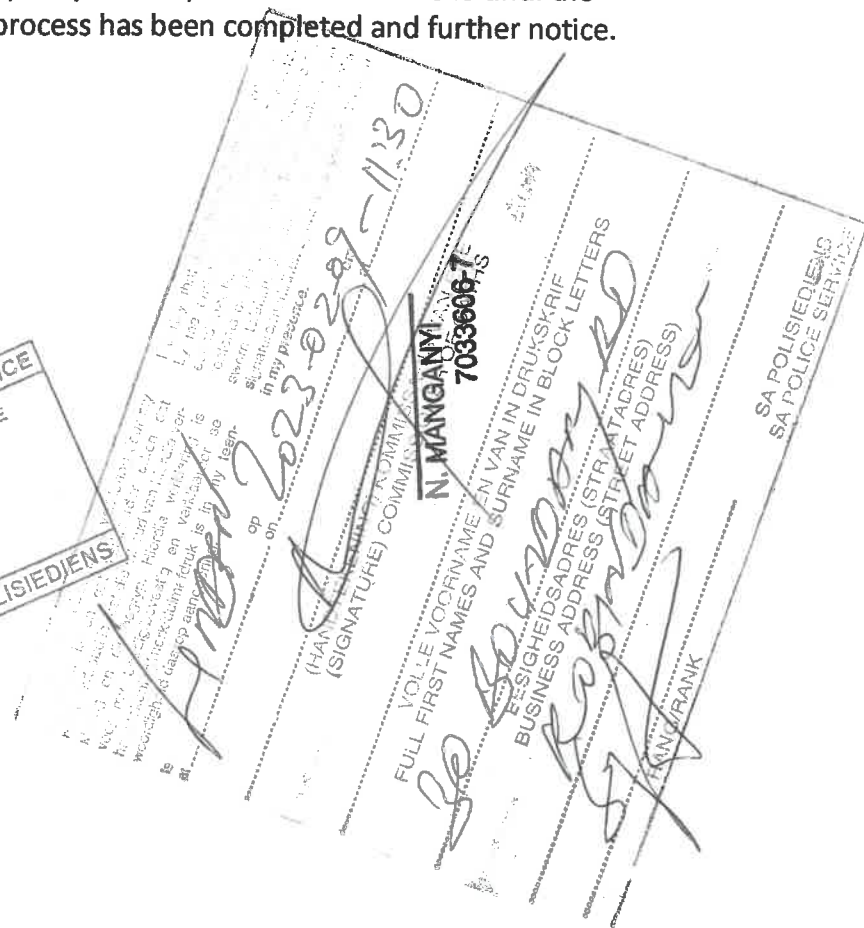
I will upon request forward the liquidation letters to the relevant people once the process has been completed.
