 - ii. On or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalization prior to that date

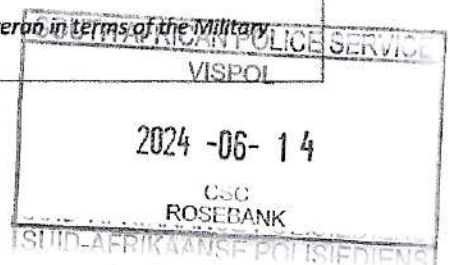

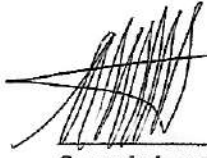
